#### Introductions:

All members introduced themselves and a new member Pam Jarvis was welcomed. DJS then explained the formation and ethos of the group and welcomed Joy Youart to the meeting and she gave details of the formation of the commissioning group and what stage it has reached. She explained that the PCT will be the statuary body until the 1st April 2013. There are 226 Commissioning Groups in total and they should all be live by April 2013. The Kernow Clinical Commissioning Group is in the first wave of those to put themselves forward for acceptance to the National Commissioning Board and they have had to prove that they are fit for purpose in 119 criteria areas, she is pleased with the progress being made and they hope to be accepted and authorised shortly. The governing body, of which, Joy Youart is Managing Director Designate includes six GP members from all over Cornwall, the East Cornwall representative is Dr. Ian Chorlton. The aim is to make the decision making process quicker and there will be more emphasis on input from local Doctors and local people to ensure that clinicians and the public work together to make best use of limited recourses. The size of the commissioning group will give the safety of a larger group but the local input should help to ensure local needs are met.

A question was raised concerning the use of the local hospital rather than a trip to Derriford, and this is an example of how local input will be used to ascertain what is needed at the hospital at Liskeard. The manager of the hospital, Jo Beer, is to be asked to come to a future meeting of the group so that ideas can be put forward, it is a good time to be doing this in view of all the changes taking place.

DJS on behalf of everyone thanked Joy for coming to the meeting and she said how pleased she was to have been asked as any opportunity to speak to members of the public such as this helped her to understand peoples issues and how they can be dealt with most effectively.

#### Matters Arising:

Car Parking Charges: DJS met Sheryll Murray MP and whilst she was aware of a problem concerning parking charges she was not aware of how difficult it was for the patients at Rosedean, she will discuss the issue with the Council.

Peoples Commissioning: The meeting was cancelled as very few people indicated that they wished to attend.

Umbrella group to elect a Chairman. If voting required on any issue each surgery to have 1 vote and a simple majority would make the decision

To act as consultees for the Locality Group where patients opinion is sought.

To share ideas amongst the surgeries and with the Locality Group

To share good practice

To support each other to develop as effective PPGs

To raise issues and if they are common across the surgeries take them to the Locality Group. Individual issues should be taken up with the manager of the practice concerned
